## Revised June 19, 2022 WAIVER OF CLAIM FORM

I am aware that, by signing this document for participation in the outdoor activities such as camping, kayaking, swimming, canoeing, washer game, horseshoe offered by the owners of the LeBlanc trailer, that certain activities are physically, mentally, socially, and emotionally demanding. Furthermore, I understand that certain risks and dangers exist with these activities in which I will be participating.

These risks include but are not limited to the following:

- loss or damage to personal property;
- injury or fatality due to inclement weather;
- slipping, falling, insect bites, falling objects;
- immersion in cold water, hypothermia (cold exposure);
- hyperthermia (heat exposure);
- suffering any type of accident or illness in remote areas without easy access to medical facilities, or while traveling to and from the activity sites;
- using kayaks, canoes, and swimming;
- using BBQ and other propane devices; and
- fire pit.

I acknowledge that in spite of reasonable efforts undertaken by the owners of the LeBlanc trailer to minimize all known risks, all dangers (hazards and perils) associated with the activities cannot be foreseen. I have a duty and a responsibility to follow the safety standards, guidelines, and procedures established by the guide, and will make them aware at any point during the activity in which I question my knowledge of these standards, guidelines, and procedures or my ability to participate.

I understand and assume all dangers (hazards and perils) and risks associated with these activities and waive all claims or causes of action that may arise. I do hereby release all persons and owners of the LeBlanc trailer from liability whether caused by, employees, gross negligence, breach of contract, strict liability, or otherwise which I may have against the owners of the LeBlanc trailer, its successors and assigns, its agents, employees, volunteers, and their heirs, executors, and assigns.

Furthermore, I give my consent to the members of the staff or other medical personnel to treat me in an emergency situation. My signature on this document is also intended to bind my successors, heirs, representatives, administrators, and assigns. By signing this <u>Waiver of Claim form</u>, I indicate that I have read it.

I agree to be responsible for all damages or loss of kayaks or canoes and other equipment during the rental period.

I have the responsibility of knowing and using: the security signs, proper environmental ethics, as well as, the proper ethic towards anglers, other canoeists, kayakers, and swimmers. I also have the responsibility of knowing the take-out area and the risk involved in the canoeing, kayaking, and swimming activities.

I am aware that the owners of the LeBlanc trailer, that I am renting from, are not responsible for accidents, loss and/or damage of personal materials, damages, injuries, and/or fatalities that could occur while swimming, and during the use of kayaks, canoes, and camping equipment. I confirm by signing and dating this document that I have read the above information.

I will also abide by the "Rules and Regulations of the Camp Grounds", as well as, the LeBlanc rules regarding the rental of the trailer which are as follows:

• A damage deposit of \$250.00 is required. An inspection will be done when you are ready to

leave and if there is no damage, your deposit will be returned to you.

- All pets must be tied in the parc;
- Noises such as loud music should be brought down to a respectable volume after 10:00 p.m.;
- No big parties allowed;
- Before you leave, please make sure all games are put back in place;
- Dishes should be cleaned and put away;
- All dirty towels and beddings should be all placed on the shower floor;
- All pop bottles, juice containers, and liquor or beer bottles should be put in a garbage bag and left on the deck unless you want to take it with you;
- Fridges should be cleaned out and whatever is good, take it with you or put in the garbage; and
- Garbage needs to be picked up and brought to the big garbage bins at the entrance of the park.
